

**Student/Parent Laptop Agreement  
Dew Independent School District  
2010-2011**

**Terms:**

Before taking possession of the property, you are to read the Dew School District's Parent/Student Laptop Agreement, Policies and Procedures and Acceptable Use Policy and sign this document as your acceptance of these conditions and responsibilities. Failure to comply with this agreement will end your child's use of this property.

**Title:**

Legal title to the property is in the District and shall at all times remain in the District. Your right of possession and use is limited to and on condition of your full and complete compliance with this Agreement and the Dew Laptop Policies and Procedures.

**Liability:**

If the property is not timely returned, is damaged, lost, or stolen, you are responsible for the reasonable cost of repair or replacement value on the date of loss according to the Fees Assessed chart below. In the case of theft or loss, a police report must be filed and the District notified the next school day after the occurrence. If the laptop is lost because of negligent or deliberate action not covered by the District, you are responsible for the entire replacement costs.

**Repossession:**

If you do not timely and fully comply with all the terms of this Student/Parent Laptop Agreement, the District shall be entitled to declare you in default and take legal steps to recover the property.

**Term of Agreement:**

Your right to use and possession of the property **terminates not later than the last day of the school year** unless earlier terminated by the District or upon withdrawal from the District.

**Appropriation:**

Your failure to timely return the property and the continued use of it for non-school purposes without the District's consent may be considered unlawful use of the District's property.

**Fees Assessed:**

The reasonable cost of repair chart below is for any damage **whether accidental or deliberate.**
